### **ORDER**

In supersession of Department of Official Language, Ministry of Home Affairs' Order No. 1/16034/01/2005-O.L.(Policy-1) dated 14.8.2006, in terms of Section 5(1) of the Right to Information Act, 2005, the Officers of Department of Official Language are hereby designated as Central Public Information Officers and the Appellate Authorities under Section 19(1) of the Act for the subjects shown against them.

2. The objective of the assignment to CPIOs and Appellate Authorities is to enlarge the number of CPIOs and Appellate Authorities for three reasons:- sensitization of a larger number of officers of the Department of Official Language and its Subordinate Offices to the provisions of the RTI Act, 2005 as amended from time to time; ensuring provision of more relevant and accurate information by the officer handling the specific subject; and lastly, but not the least, enhancement in the level of satisfaction and convenience by having Appellate Authorities at physically proximate level for the applicants seeking information under the RTI Act.
